The False Claims Act, 31 USC § 3729 et seq, provides for liability for triple damages and a penalty from \$5,500 to \$11,000 per claim for anyone who knowingly submits or causes the submission of a false or fraudulent claim to the United States The statute, first passed in 1863, includes an ancient legal device called a "qui tam"
